The independent, voluntary regulator of charitable fundraising in England, Wales and Northern Ireland.




This annual review provides a snapshot of the progress that the Fundraising Regulator has made in our first year of operation. Working closely with our partners, with donors and with the charitable sector, we have fully met the initial expectations set out in the Cross-Party Review of Fundraising. The sector's approach to fundraising has shifted significantly since early 2016, not least in relation to the consents needed to contact donors. Complying with legal requirements should not be a matter of dispute; equally important, however, is a commitment to ethical fundraising and best practice. Charities can demonstrate that commitment by paying the levy and/or registering with the Regulator, and in turn signing up to the Fundraising Promise.

There are some signs, I believe, of a revival of public confidence in fundraising. We will continue to work hard to ensure that best practice becomes the norm in 2017/18.

The Fundraising Regulator is the independent voluntary regulator of charitable fundraising in England, Wales and Northern Ireland. The Regulator is also a partner in the co-regulatory arrangement in Scotland. It was established in January 2016 following the **2015 Cross-Party Review of Fundraising Regulation.** The review set out six performance indicators for the new Regulator to achieve within its first year:



We have a Board of Directors, Standards Committee & Adjudications Committee



The fundraising levy has been set with a banding system



We have signed a Memorandum of Understanding with the Charity Commission and other partners



We are responsible for upholding and amending the Code of Fundraising Practice



There has been a significant number of levy payments and charity registrants

On the day of our launch, we took ownership of the Code of Fundraising Practice and the Rulebooks for Face-to-Face Fundraising. We are responsible for maintaining and amending these standards to suit the needs of both the sector and the public. In February 2017, we launched our first consultation on changes to the Code.
